



## **BROOK INFANT SCHOOL AND NURSERY**

### **FAMILY SPLASH SWIMMING SESSIONS TERMS AND CONDITIONS.**

#### **Sessions**

- Swimming sessions will be made available on the 30<sup>th</sup> March, 31<sup>st</sup> March, and 1<sup>st</sup> April 2026.
- These sessions will be bookable in slots of 30 minutes, but more than one session can be booked. See booking system for details of times and availability.
- Swimmers-Ed will provide one lifeguard for each session. They will not be in the water.
- Sessions are not lessons or for party groups. Sessions are offered for family swims and can be booked for up to two families in one session.
- Sessions are available to anyone in the community you do not have to have children attending our school and nursery.
- Sensory swims for SEN children may be offered for up to 5 children with a ratio of 1 child to 1 adult in the water. This should be discussed with the school office. Please contact Emma Taylor on [schooladmin@brookinfant.school](mailto:schooladmin@brookinfant.school).
- We reserve the right to move your session to an earlier or later slot to avoid gaps between bookings.
- All session must be booked via <https://buytickets.at/brookinfantschoolandnursery/2027897>.
- Walk ins cannot be accepted.
- Initially only morning sessions will be available but if these get booked afternoon sessions will be opened for bookings.
- Sessions are available at £25 for 30 minutes and a discounted rate of £45 for 60 minutes for consecutive sessions being booked.

## **Health and Safety**

- Parents/Carers are responsible for their child and must remain on site in the swimming tent during the whole booked session.
- Whilst in the swimming area the lifeguard is in charge and responsible for health and safety. Children and Adults should follow all instructions.
- Parents/Carers are expected to be in the pool in the following ratios:-
  - Children under 7 or SEN children - 1:1 ratio.
  - Children over 7 - 1:2 ratio
  - Children under 1.2m - 1:1 ratio
- No food or drink can be consumed within the tent or changing area.

## **Practical Information**

- Enter via the pedestrian gate which should be unlocked. If this is locked, please buzz. Please be patient as staff may not be in the office.
- Arrival in the swimming tent is 15 minutes before the booked session as this is the time that you have to change. The changing rooms are in the tent and are enclosed with a curtain screen. There are two changing rooms available.
- Families must be ready to go into the pool at their booking time.
- All clothes etc., to be stored in the crates provided and put outside the changing rooms.
- Any child in nappies or potential of soiling themselves, must wear a double nappy. i.e., a swim nappy plus a neoprene nappy on top. Any accidents in the pool will close the pool for the remaining sessions/days.
- On finishing the session there will be 15 minutes to change before the next family arrive.
- The disabled toilet in the reception area of the school will be available to use. Please do not change in here.
- All adults and children must leave site 15 minutes after their session has finished.
- There is no parking available on site. Spaces are available outside school within the layby.
- If your child is unwell, please do not bring them.
- Please note that there may be another session going on in the pool whilst you are changing.

## Other Information

- Parents/Carer accept liability for their children while on the school site.
- Swimmers-Ed are responsible for health and safety in the swimming tent.
- Brook Infant School and Nursery do not accept any liability for any personal items that get damaged or lost whilst on the premises.
- If the swimming pool must close and your session time has not started, a refund will be given. If the session has started, a refund may not be given.
- Parents/Carers will be responsible to reimburse for any damaged cause by them or their children.

- The full fee will be charged for cancellations less than 48 hours.
