## A guide to your child's Nursery Fees

This short guide aims to explain how your child's nursery place at the Brook Infant Nursery can be funded.

## Is my child entitled to free Government funding for nursery places?

Yes. Every child is entitled to 15 hours of free nursery education from the term after they are 3 years old. So, for example, if your child has their $3^{\text {rd }}$ birthday on $15^{\text {th }}$ September, they will be entitled to 15 hours of free nursery care from the Spring term starting in January.

Some working parents may also be entitled to an additional 15 hours ( 30 in total) per week. The criteria for the additional 15 hours is as follows:

- Both parents are working (or the sole parent is working in a lone parent family) AND;
- Each parent earns, on average, a weekly minimum equivalent to 16 hours at national minimum wage (NMW) or national living wage (NLW) and earn less than $£ 100,000$ per year.

Please note this includes employed and self employed parents as well as parents on zero hour contracts who meet the criteria. Parents who are on maternity, paternity or adoption leave or those who can't work because they are disabled or have caring responsibilities, could also be eligible.

## Do I have to claim the free sessions from the government?

No, for the initial 15 hours we do this for you. All you have to do is complete a parent declaration form for the initial 15 hours free nursery education and provide us with a photocopy of your child's birth certificate and we will do the rest. Forms will need to be updated when the number of funded hours claimed changes.

Parents who think they may be eligible for 30 hours free childcare should visit www.childcarechoices.gov.uk. An application must be made in the term BEFORE their child starts Nursery to receive funding as shown below:

| When your child turns 3 | When they can get 30 hours from | Recommended time to apply |
| :--- | :--- | :--- |
| 1 September to 31 December | 1 January | 15 October to 30 November |
| 1 January to 31 March | 1 April | 15 January to 28 February |
| 1 April to 31 August | 1 September | 15 June to 31 July |

Please note that all parents wanting to claim 30 hours free nursery care for September 2020 are encouraged to do so by $31^{\text {st }}$ July 2020 to ensure they receive their code in time.

On completion of application, parents are given a unique code which they must then write on to their Free Entitlement Declaration form - this code is then used to request funding.

Parents will then be contacted termly by the Government and asked to update their details. Unfortunately if details are not updated or an application is not made on time then, the funding is withdrawn and additional hours are chargeable. Please note it is parent's responsibility to update their status with the Government termly.

## What if my child attends two nurseries?

Currently under Covid-19 restrictions, children are not allowed to attend two settings, but once this is lifted, children can attend two settings but you are still only entitled to the total 15 hours (or 30 hours if you are eligible). The funding relates to the child not the number of nurseries you attend. When you complete the parent declaration form you can state how many nurseries your child attends and how many of your hours you wish to claim from each nursery. We will then claim the number of hours you have allocated. Any hours attended over the government funded hours for that nursery will be chargeable.

## How will I be charged for any additional hours? (above the government funded hours)

Any hours attended by your child not covered by your government funded hours will be charged at $£ 6$ per hour. Parents will receive an invoice for this at the start of each term. Please note you will only be invoiced for chargeable hours and can pay in full or by instalments. Payments can be made by child care vouchers, electronic transfer or tax-free childcare scheme.

## What times can my child start and finish nursery?

Our nursery day is split into two 3 hour sessions. This is 8.30 am to 11.30 am and 12 noon to 3 pm .
If your child attends all day then you can have two options:

1. Start at 9 am and finish at 3 pm (this is a 6 hour session)
2. Start at 8.30 am and finish at 3 pm (this is a 6 hour 30 minute session)

Please can you give me an example of the cost for any additional hours above the government funded hours?

An additional 3 hours per week $=£ 18.00$ per week (one 3 hour session)
An additional 6 hours per week $=£ 36.00$ per week (two 3 hour sessions)
An additional 15 hours per week (full time with government funded hours) = $£ 90$ per week
